Any and all exterior improvements to your property must be submitted to the Architectural Review Committee (ARC) for review and approval prior to commencement of work. After approval is received, all owners must then submit for approval to the Wilton Commons Homeowners' Association prior to the commencement of any work.

The following details the procedure for submitting improvements for review by the Architectural Review Committee:

1. Submit one (1) COMPLETED copy of the Architectural Change Request Form, Neighbor Awareness Letter and drawings/plans/samples, etc. to:

Drawings MUST INCLUDE location and screening of equipment, site plan, setbacks, materials, colors and any information pertinent to the proposed improvement such as brochures, pictures, etc.

2. Upon review of your plans by the ARC Committee, you will receive written notice of their approval, rejection or conditional approval within sixty (60) days of submittal of a completed application.

CONSTRUCTION/WORK MAY NOT BEGIN UNTIL WRITTEN APPROVAL OF THE PLANS IS RECEIVED FOLLOWING THE ACHITECTURAL REVIEW.

To avoid construction delays, please ensure forms and plans are complete prior to submittal.
